It's not always easy being Catholic. Draw from your personal experience and discuss some of the challenges you've faced in

Whether it's heartfelt or lighthearted, the tone of your spot is completely up to you, but remember to keep it tasteful and mindful of EWTN's audience. Modesty is the best policy for your wardrobe choices here, so avoid having your actors wear low-cut tops, short shorts, short skirts, short dresses, tank tops, crop tops, apparel and props with company logos or images.

Eligibility & Entry Guidelines

- Group one must be at least 14 (fourteen) years of age by March 28, 2025
- Children of employees of EWTN, EWTN stations or their affiliates, representatives, subsidiaries or parent companies, and judges are not eligible.
- To be eligible, an entrant must be a legal resident of the fifty (50) United States and D.C. (excluding Puerto Rico, USVI and American Samoa). EWTN reserves the right to disqualify ineligible entries; such entries will not be returned.
- EWTN has the right to verify the age of any contestant, and all winners will have their age verified as a condition of being granted an award.
- All Submitted Materials become Property of EWTN.
- EWTN has no duty to return or safeguard entries, and any entry not used by EWTN and non-eligible entries will be destroyed.
- Only one entry per person will be accepted in this Contest; all subsequent entries will be disqualified.
- You can work with your friends to make a video, but only one winner will be brought to EWTN. The author submitting the video is the producer and will be the winner named.
- Films can be fact or fiction.
- Any failure to adhere to these Contest Rules may result in disqualification from the Contest.
- No purchase is necessary. Many will enter; few will win.

Video Submission Requirements

- Video must be at least 30 seconds, but not longer than 120 seconds.
- Content of the video must not teach against the faith or promote immoral concepts. Just like all other EWTN programming, the EWTN Theology department will be the final judge of submitted video content for moral and faith fitness.
- Because the submission must be free to air, and become property of EWTN, you must clear the rights of any materials you use in your video submission: Stock agency materials (video, music, photos) must be royalty-free, attribution-free*, and no share alike licensing.

Clips must be free to use for promotion, so Editorial use only restrictions are not allowed.

Music must be free from Performance Rights Organization (PRO) royalties and requirements.

A location release is required for any non-public ground or any non-public place, except for your own home, that gives you permission to record video and take photos on that property.

* Generally, attribution requirements are not reasonably met in video clips because you must use screen space during the clip. Materials that require an attribution and the attribution is part of your video itself (not in credit roll or extra material) can be acceptable, so long as the attribution requirement is actually met.

At the time of announcing the EWTN Studios Lux Student Film Contest, we are aware that *soundotcom.com* provides music that meets these requirements.

You must document each material used in your video submission and show the licensing of each item. If the video license was acquired by a membership or paid, you must show that you were a member or paid for the video license as well.

• NO ENTRIES MAY be submitted by mail and will be disqualified.

Official Entry Form

- Each entry must complete and submit the online official EWTN Studios Lux Student Film Contest Entry Form, with the required signature of a parent/guardian, consenting to allowing their child/ward to enter the Contest, confirming that the Video and art are original, and granting certain rights to the entry materials.
- The entry form must be complete and legible to be eligible.

Judging, Awards & Notification

All entries submitted will be judged by a panel of judges from EWTN and the film industry. The entries with the highest vote counts will be deemed the winners. Judging for the national judging round of the Contest will occur on or about October 2025. The judging criteria and percentages used by any judging in connection with the judging round of the Contest shall be scored and graded using a rubric based on the following criteria:

Originality, content, creativity and relevance to EWTN's Mission.

All decisions of the judges are final and binding and not subject to appeal or review.

Prizes Winners will receive: Three (3) winning submissions will be selected. Winners will be engaged as freelance production assistants for EWTN at SEEK, where they will provide support at the booth and assist with interviews. Each winner will receive an all-expenses-paid trip to Columbus to work with EWTN. Winners will appear as a guest on a LUX special (TBD) to present their winning video. Additionally, winners will be awarded a short-form content development deal, which includes a stipend. This stipend is subject to taxes, and winners are advised to hold onto their receipts.
